## Minutes, Treasurer's Report and Bills:

Minutes from the September board meeting were approved. There were no questions regarding the treasurer's report. We did receive the tax anticipation note and will be operating with those funds until approx. December

## Correspondence:

Chief Ney shared that LFA received two phone calls praising the contributions of our firefighters that were a part of the task force that went to the California fires.

## Chief's Report:

**California Conflagration** – 75 engines from Oregon were sent. Lane County sent two strike teams. Demobilization began today (October 19<sup>th</sup>) with LFA crews coming home the 21<sup>st</sup>. Oregon contracts for portal to portal pay.

**Coast Guard Boat** – LFA has acquired a 25' Coast Guard FEPP boat with an enclosed cabin, a triple axel trailer and two large outboards (which we need to pay for). We may want to consider selling the smaller boat.

**Medic Hiring** – With one member of the medic staff out for the next 30 days, Chief Ney is declaring a hiring emergency. LFA recently hired two medics, Kavi Taraka and Brandon Bowers. Bowers resigned last week after recognizing his limitations in being able to fulfill the position.

Chief Ney would like to look at a candidate from the last hiring process that was unable to attend the interview due to his wedding. A lateral hire would satisfy the Safer Grant. The Union and staff support this.
